General Reasonable Necessity Statement

The department proposes to amend ARM 18.8.511A to remove contradictory language pertaining to the width requirements on non-interstate highways for when pilot vehicles are required.

Rulemaking Actions

AMEND

The rule proposed to be amended is as follows, stricken matter interlined, new matter underlined:

18.8.511A WHEN PILOT VEHICLES ARE REQUIRED

- (1) Unless otherwise specified in statute, rule, or the terms of the special permit issued to the permittee, pilot vehicles are required if one or more of the following conditions apply:
 - (a) Non-Interstate highways:
 - (i) remains the same.

(ii) Width – loads exceeding 16 feet 6 inches to 18 feet must have one front and one rear pilot vehicle; ~~length over 120 feet, one rear pilot vehicle;~~

(iii) through (vi) remain the same.

(b) through (d) remain the same.

(2) through (7) remain the same.

Small Business Impact

The proposed rule amendment removes language inadvertently retained during the last update to this rule. The language proposed to be removed contradicts other language within ARM 18.8.511A, which details the requirements for pilot vehicles for overlength commercial vehicles. Because of this, small businesses are not affected by the removal of the language in the rule. The record of the department's small business impact analysis can be provided upon request.

Tribal Impact

With regard to the requirements of 2-15-142, MCA, the department has determined that the proposed amendment solely clears up any potential misunderstanding and contradictory language within the rule, and does not impose new regulations, costs, or restrictions on tribal governments or their entities. As such, the proposed amendment of the above-referenced rule will not have direct tribal implications.
